INSTRUCTIONS: This form is used for submitting a “Request to Know,” a “Request to Delete,” or a “Request to Correct” under the California Consumer Privacy Act of 2018 (“CCPA”) as amended by the California Privacy Rights Act of 2020 (“CPRA”). Residents of California have a right to know what personal information is being collected or shared about you, a right to seek correction of any inaccurate personal information about you, and a right to seek deletion of personal information about you (excluding certain information that is excepted from deletion).
