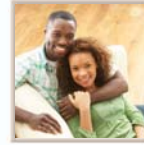

Regulation D transfers made between your accounts...

The Credit Union offers several funds transfer programs. Our overdraft protection program allows a member to automatically transfer money from a savings account to cover checks when there is an insufficient balance in the checking account. We also offer preauthorized transfers from members' accounts to third parties (such as an electronic payment to an insurance company) as well as transfers made via CUE Phone, PC Cuing™ and MobileAccess+.

Federal Regulation D limits these types of transfers to 6 times in one month. Consequently, the Credit Union will not transfer funds from an account, except to make a loan payment with the Credit Union, when the transfer would exceed this monthly limit. Also, if a transfer is not made and a check is returned due to insufficient funds, a fee will be assessed. (The check will not be returned if the member has a Line of Credit on his/her account with sufficient funds available.) Please note, this Regulation does not limit the number of transfers made via ATMs or at a lobby teller. MobileAccess+ consists of three services:

Text/SMS Message

Send text message commands to obtain balances, view history and transfer funds.

Mobile Web & App

Use your mobile device to view balances and history, pay bills and transfer funds.

Text Alerts

Receive account alerts via text message (i.e., balance alerts, direct deposits).
